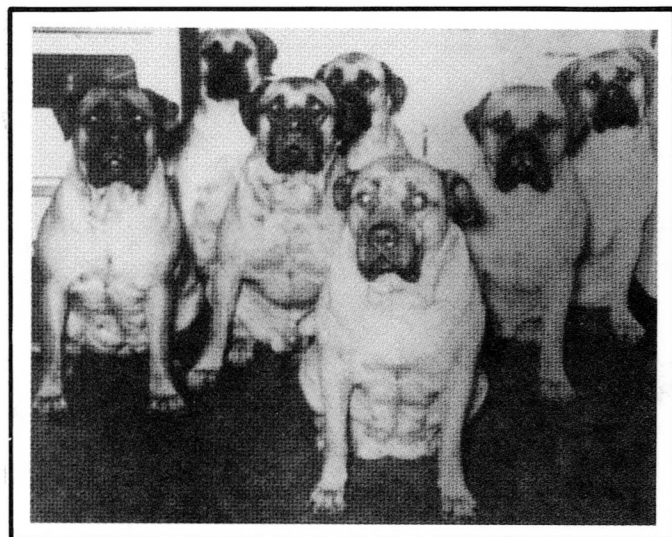

# Sweepstakes Overview

## 1986 A.B.A. National Specialty Show

**JUDGE: MRS. VIRGINIA A. STARK**

In my experience as a Bullmastiff breeder, one of the things I have observed is that the road to maturity for this breed is paved with dramatic change and Sweepstakes classes are the theater event for viewing this extraordinary developmental process. The one constant that doesn't seem to be measurably affected by physical transformation is temperament; overall, disposition of the youngsters exhibited in the Sweepstakes classes this day was a vivid tribute to the breed and a positive statement about the numerous breeding programs represented.

Diversity of head type was present this day but there was a preponderance of large skull, strong muzzle and good expression. In general, mouths tended to be undershot ranging anywhere from slight to shocking. Eye color was good overall with only a few instances of lighter than desirable eye. Pigment, as a whole, was agreeable; faded or heavily shadowed exhibits were in the minority, coats were predominantly in excellent condition.

Component elements which can affect the maturation process are lineage, rearing and nature (not necessarily in that order). Consequently, Bullmastiff pups do not structurally develop at a standard rate or in a reliably predictable pattern. Bearing this thought in mind, there is bound to be variance in size and body structure, especially among and within the younger Sweepstakes classes. However, I was genuinely impressed with the high percentage of exhibits possessing ample size and substance of bone. Breeders are to be complimented for their efforts in these areas. Solid toplines were also in the majority; would have liked to have seen fewer long backs.

Clearly, there were numerous exhibits with strong front reach and powerful rear thrust to observe this day but, movement is always a tricky area to evaluate in youngsters. I did see a number of loose fronts and/or faulty rear quarters but, again, age may be a determining factor and with time there may be some improvement.

I selected the Best in Sweepstakes winner from the 9-12 month puppy dog class. My final decision was based on the strength of his breed type, overall balance, size and substance. This handsome specimen had the added dimension of being a true showman — he demonstrated confidence and style while in the ring. My Best in Sweepstakes winner went on to capture the Winners Dog placement in the regular classes against formidable competition.

My choice for Best of Opposite Sex to Best in Sweepstakes went to a substantially put-together red fawn bitch. Coming from the 15-18 month puppy bitch class, she possessed strong breed type without being coarse in appearance or compromising her femininity. I felt she complimented my choice for Best in Sweepstakes.

Last, but not least, a few comments directed to the exhibitors and show committee. My task as your Sweepstakes judge was made easier because exhibitors were courteous and cooperative. Thank you for your good sportsmanship and the opportunity to evaluate your Bullmastiffs. The show organization was administered with admirable efficiency and to the Show Chairman, Committee and Ring Stewards, this was truly a classy event made memorable by your efforts. THANK YOU ALL.

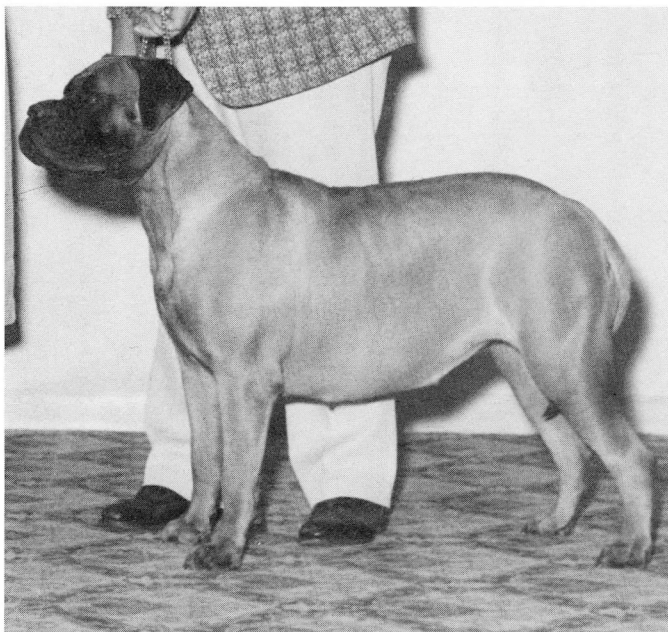

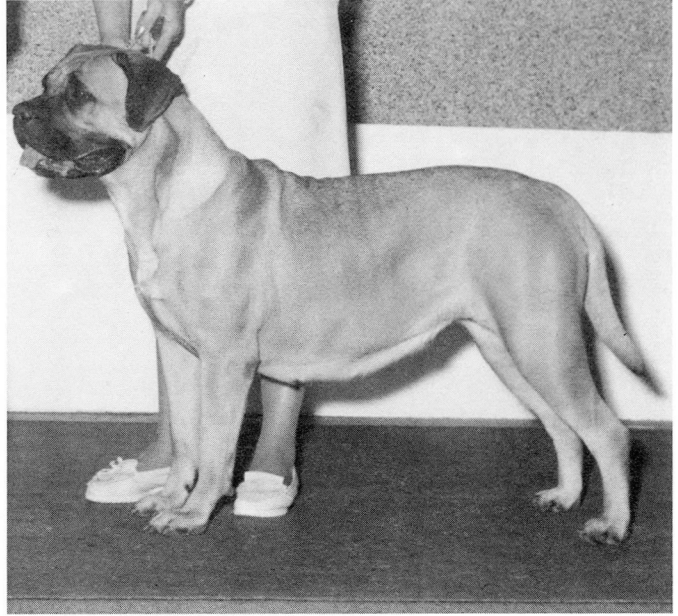

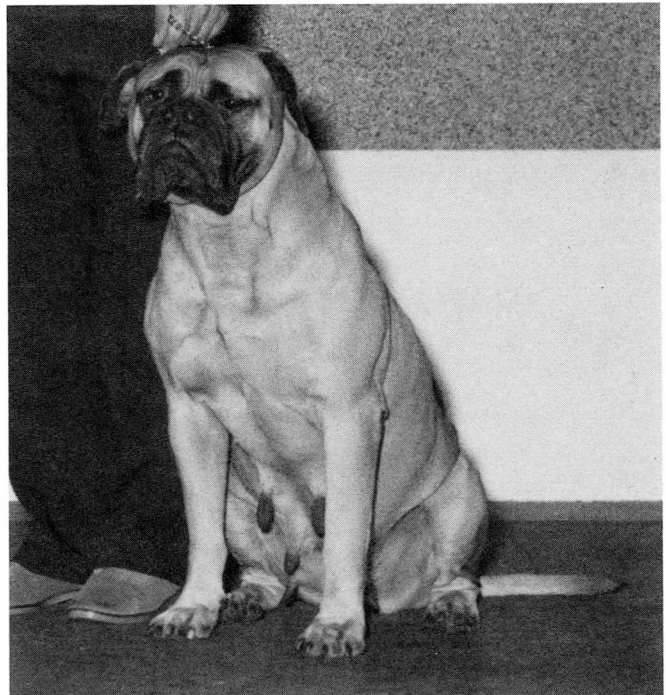

Set up of the show site and grounds began on Wednesday and continued through the opening of the show on Friday. All of the mats, ring barriers and obedience equipment was hauled (literally) to the show site by Chris Rasmussen, involving several round trips of many miles each. It was then all hauled away by that same wonderful person. All of the above mentioned people, as well as Lester Knack, Charlie Murphy, Jr., Mary Joe Peters, Marilyn Cather and Dave Burkett helped to set up the show site. Both John and Jeff have spent hours on our behalf and we sincerely thank them both! Mr. Kim Booth our official show photographer of Martin Booth Photography did all of the fantastic show pictures. We were so lucky to have him with us. Kim has provided a beautiful album of Specialty pictures for the Archives. Have had so many people ask in amazement — how did you get him? Thanks, Kim!

With Welcome Packets waiting at the desk, and more passed out at the dinner, exhibitors started arriving on Wednesday. Thursday evening found several groups at Sully's, a fine local restaurant, for what turned into an evening of fun and a particular brand of fellowship indigenous (fortunately or unfortunately, depending) to the Mid-West. One table was swept up in the levity when *someone* mistakenly thought they were Patty and Mark Stephens. It seemed the bull —

they were speaking about was not a Bullmastiff, but a bull! in residence on their dairy farm! We were embarrassed, they were charming!

On Friday at 5:00 PM the Atrium Ballroom was ready and thus began the ABA's first two-day independent national specialty show. Depending on your outlook, it was either all up-hill or all down-hill from there. I (even though fortified with birch beer [non-alcoholic] and Tasty Cakes imported from the East) still felt at one point (no, at several points) like I was losing it, had lost it or, would lose it! During the event several suggestions were made. Please be assured that these, along with my own copious notes, have been filed — for future reference of course . . .

Also the Duchins provided the informative page on Obedience in the catalog telling us all the things we all wanted to know about Obedience, but were afraid to ask. Finally in regard to Obedience, we all have Joel to thank for the idea of having the Trial on Friday evening. His suggestion provided us with a very special evening of Bullmastiffs In Obedience!

The ABA Hospitality evening hosted by the Mid-West and Glass City Fanciers at poolside, followed the exciting evening of Obedience giving us all a chance to relax and chat. It was a beautiful presentation by the Holidome staff. The very special cake was provided by Mrs. Clarise Ellison and was transported all the way from Toledo. Since we could do nothing about it, we must consider the fact that it rained into the pool as well as into the Atrium Room, as added effect!

As clear skies dawned (a term usually reserved for outdoor shows) Sweepstakes Judging began promptly at 8 AM and our Judge Mrs. Virginia Stark had a lovely entry to preside over. While we were all pleased with the clear skies, as the time went on it became evident that not only was it getting WARM, but that there were obviously people on the roof, *trying to be quiet and not fall through the skylights. It turned out that while we had indeed lucked out with the weather, now the air conditioning had failed.* Needless to say — your Show Secretary remained calm! By the end of the lunch break "it was fixed" and the room was bearable for the rest of the day.

Regular and Non-Regular Classes provided us with still more beautiful Bullmastiffs. While the Specials could not move out when they were all in the ring together, the idea was an exciting one. It was in impressive sight as they all stood there and were oh so well behaved. We all gazed in wonder as Mr. Honig gave his instructions, gave us time to gaze and then led the applause for the entire group. While we were prepared to move a barrier and open the ring another 20 feet, Mr. Honig instructed that all should remain as is, as he felt 10 at a time in the ring would give the exhibitors and dogs a goodly amount of room and would provide the spectators with a good view of each group.

The Best of Breed Competition was followed by Stud Dog, Brood Bitch and Brace Classes, in each case a sight to behold. Then the Parade Of Veterans, with each one presenting a glimpse of the charm and quality they had presented to countless judges in their youth. What can you say about a Veteran. Ladies and Gentlemen all, they wore their flowered garlands with stoic good humor. Younger dogs, as we all know, would have at the very least tried to eat the thing. While we all clapped and cheered for each and every one, even the absent Veterans, one smiling bitch, a hero, won the hearts of all. The rafters rang! With all the travail of the past two days, this one presentation of the Veterans made the whole thing worth it. There was a very special feeling in that room, shared by one and all for the loves there, the ones at home and the ones that have gone on to better than we could give them. You could almost put your hand out and touch it. I'm proud to have been a part of it. A fine Finale!

After a very long day, the evening started with cocktails and the ABA Art Auction, which provided us all with good fun and a chance to unwind. For the unique and beautiful items, each an original, I send my thanks to the artists and donors and to Virginia Rowland for organizing. Diana Hicks received all reservations and compiled the massive list of



diners. Liz Dunn provided the Bullmastiff name tags and then both had the enormous task of checking 192 people in for dinner. Barb Ellison and Pat McGee Coordinated the set up of the hospitality evening and the dinner. No small task, what with rain pouring into the pool and over 100 door prizes and 27 tables to manage.

Chris Rasmussen presided at what turned out to be a lively bout of bidding for each item in the auction. His descriptions of each and his charm made this part of the evening a joy. Good thing everyone got their door prizes during a break in the bidding or Chris would have auctioned off everything in sight!

Dinner to the amazement of everyone, was delicious. Then, after finishing up the bidding on the auction, a LOUD voice vote determined that the raffle should commence. A TV in memory of Russ and a famous Marti Robins quilt were the prizes. Recipients were delighted and the rest of us were jealous. To the friends involved in donating the TV, I send my thanks and pride in such long-lasting friendships and, to Marti for the fantastic quilt, we all send our thanks.

Two of our three Judges, Mr. Honig and Mrs. Stark along with Dr. Reece and Mr. Peterson, were with us for the evening. Miss Graettinger, our Obedience Judge sent her regrets with the message that she was truly impressed with our Bullmastiffs in Obedience. Both Mr. Honig and Mrs. Stark spoke to the gathering and were presented with gifts of appreciation. Each assured me they were having a fine time! Throughout the weekend Lester and Milly Knack saw to the needs of all of our officials and I'm proud to report all left feeling pampered.

For those of you who know me well, to find me speechless is an event in itself. First when The Glass City Fanciers presented me with a beautiful orchid corsage with such fondness, I could but mumble thank you, then when Marti Robins and Liz Dunn presented me with their personal gift for my work on the Specialty, I was reduced to tears. A quilt with all of my loves depicted, even Ridgie! I am still speechless — well almost — Thank you!

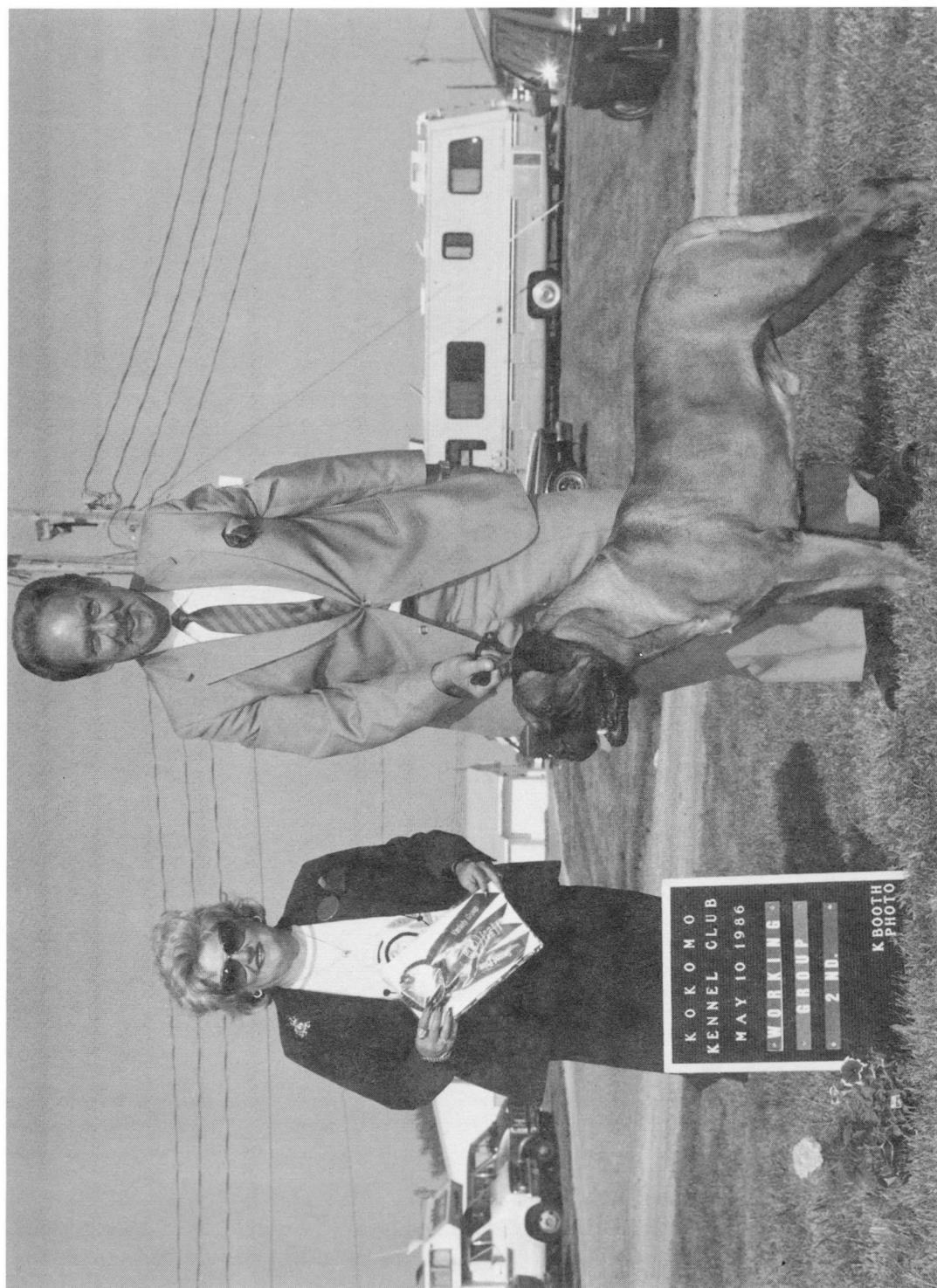

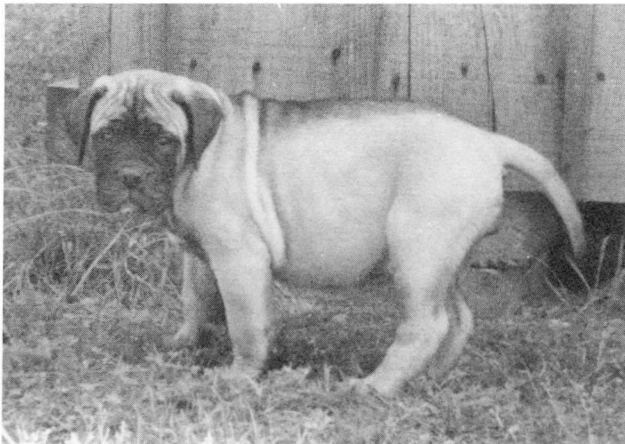
