## COVER STORY

**Ch. Chit-Sia-Yah-Lovable** bred in Canada by Kenneth & Nancy Johnson was sired by **Can. Ch. Bulletproof of Bulmas X Duchess** on April 15, 1956. This fawn male was purchased by Mr. and Mrs. Cledith Hurt of Hustacre Kennels, at the age of two years. He had attained his title undefeated in home territory. He began his American campaign under their tutelage in 1958 and completed his second title in May, 1958. His "get" numbered some 13 litters, 6 of these offspring from the **same** litter attained titles. One of the six champions from the litter of "**Chips**" and **Lady Marmaduke of Arlington** was the winner of the ABA National Specialty. One of his grandsons was the first bullmastiff to get a BIS in the States. Truly this tremendous champion has left his mark in the bullmastiff world. "**Chips**" died on March 19, 1964.

# Garden Report

The bullmastiff entry at Westminster this year was a bit smaller. Apparently quite a few exhibitors had not anticipated the early closing date (earliest ever) and had their entries returned. However, the 14 dogs and bitches competing were of very good quality and, in my opinion, quite uniform.

Best of breed went to the youngest one present, Ch. Ladybug I.M. Angelica Rose, a 13-months old red fawn bitch bred by Geraldine Roach, owned by Peggy Graham and handled by Alan Levine. As best of opposite sex judge Donald F. Starkweather chose Ch. Ridgeway's Apollo of Carabee, bred by Mark Williams and Carol Goldsmith, owned by Williams and handled by Cathy Babins. Winners dog and best of winners was Jubilee Henry Plantagenet, bred by Peter and Bodil Aczel and owned by Israel Perlman. Winners bitch was Starbrite's Honeybe Li'l Brook, bred by Janet VanZantwyk and owned by Alison Hayes and Alan VanZantwyk.

Westminster this year was particularly exciting. The scuttlebutt did not have a favorite, so competition was perceived as wide open until the end. The winner was Ch. Great Elms Prince Charming II, a Pomeranian. The press clearly did not anticipate him as top dog and there was quite a bit of scrambling to get particulars from the owners who were too excited to pay attention to all those persistent questions about records and such.

Two of last year's group winners again made the finals, the German shorthaired pointer, Ch. NMK's Britannia V. Sibelstein and the bloodhound, Ch. Viking's Thor. Working breeds were won by a lovely Doberman pinscher bitch, Ch. Royal Tudor Wild As The Wind. Terriers went to the cairn, Ch. Tidewater Master Gold. The non-sporting group was won by Ch. Alekai Airy, a beautiful black standard poodle bitch. Herding breeds went to Ch. Rockwoods Gold Strike, a breeder-owner handled Shetland sheepdog.

Three of the finalists were bitches, three other bitches placed in the groups, of the 140 best of breed rosettes, 32 were won by bitches. While that is not an overwhelming percentage, perhaps it is an indication that the ladies do have a chance.

Talking about females, the lady judges were stunningly dressed. All sparkled not just with prettiness but also with pearls, rhinestones and other glittery material on their dresses. Mrs. Billings looked absolutely smashing and I did like Eileen Pimlott's dress a whole lot. While formal attire does not have much to do with judging dogs, it does add a touch of glamour and is one of the elements which elevates Westminster above the ordinary dog show. It was fun, and if you haven't been there, plan on coming and being part of the applauding, hollering crowd which fills the Garden for group judging. By the way, I do wonder how one prepares a dog for this noisy bedlam, records perhaps? May be some of our breed winners could share the secret so that next year's contestants can prepare.

## 1988 National Specialty

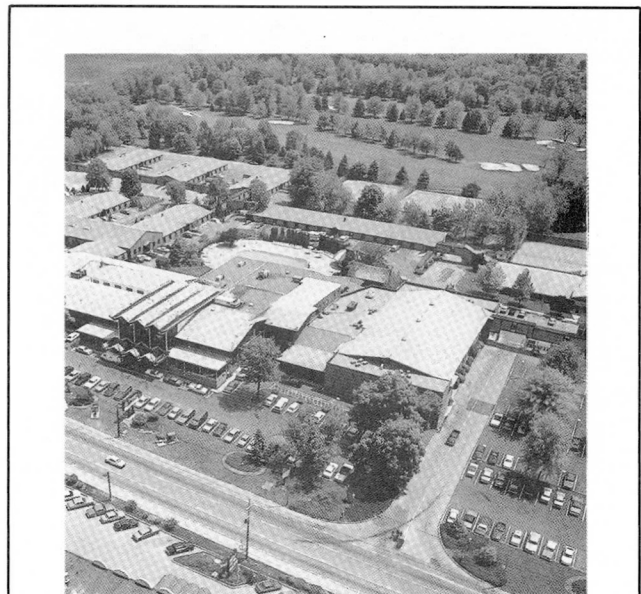

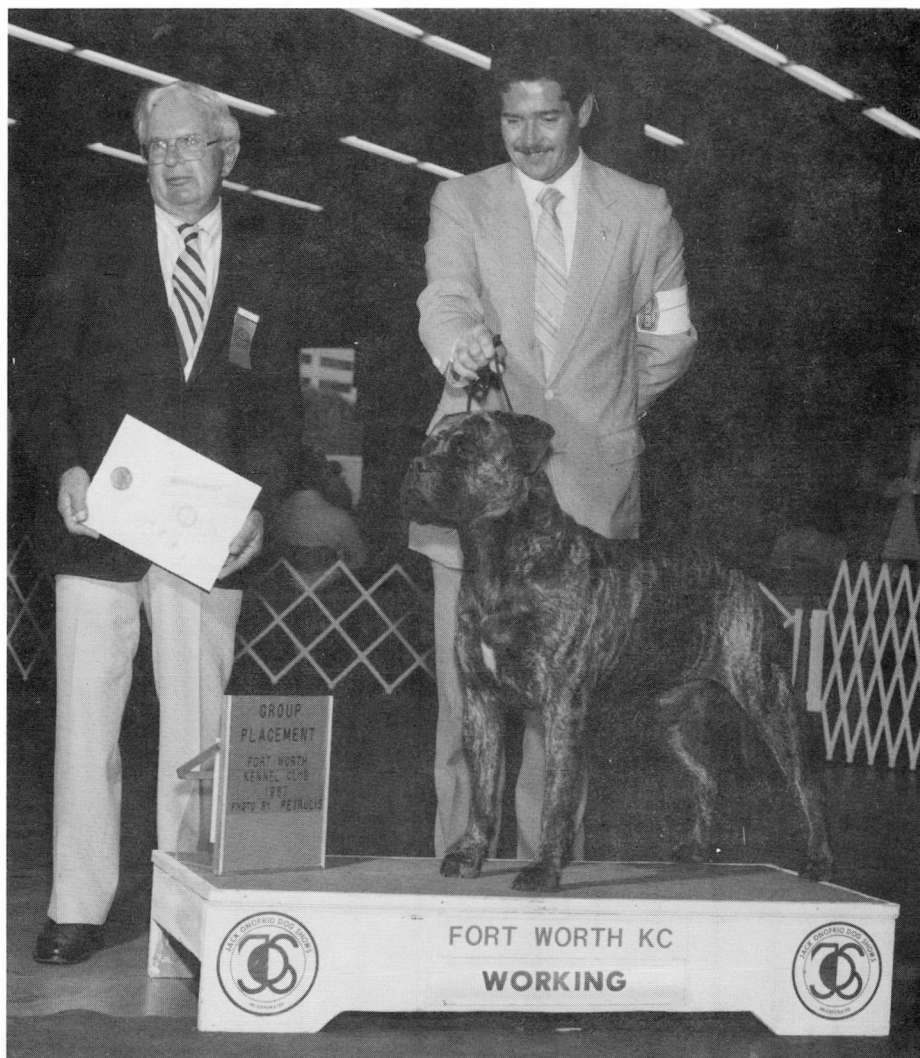

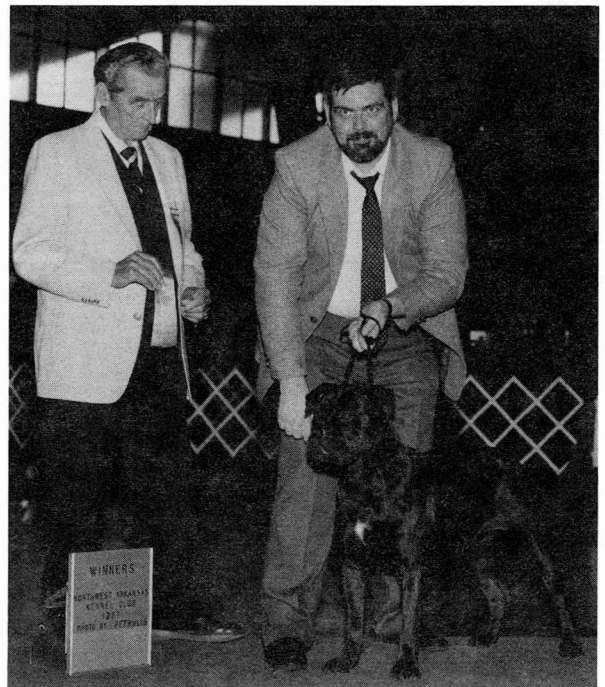

## How to Beat the Summer Heat

Summer months are coming up and in planning my show calendar I began remembering the hotter shows from last year. There was one three-day circuit in Northern California I will never forget.

I left my house about 9:00 a.m. one Friday in June with two Bullmastiffs, a Rottweiler and more supplies and equipment than a Bedouin needs to cross the Sahara. I was going to be picking up a friend and her dogs mid-state, about six hours from San Diego. As I crossed the mountains and entered the valley my friend lives in, the change in climate was noticeably warmer. I reached her house about 3:00 p.m. and we loaded up three more Bullmastiffs, her gear and her twelve year old son. With my van busting at the seams, we took off.

Six hours later we reached our motel, fed and walked the dogs, ate a quick meal and set the alarm for 5:00 a.m. It was so hot we had to sleep with the air conditioner on. The vent was open in the van and the night air was cool enough for the dogs. Luckily, we showed early the next day.

The grounds were about 45 minutes away. They were filled with trees and the rings were all in the shade, although it didn't help much. The humidity was the worst I had been in for years. We constantly sprayed the dogs with ice water from our cooler and had wet towels available to drape over them as we waited. We also fed them ice to cool them from the inside out.

After showing, we set up our pens so the dogs could eat and relax. They didn't do much of either; it was so hot. We found a hose in a field, got out shampoo and gave each dog a bath. They loved the cold water and the bath seemed to relax them more than just wetting them down. By the time we finished bathing the last dog, the first was already dry.

We drove back to the motel and exercised the dogs in the park next door to it. We have a small air conditioner on top of the van that can be plugged in to any outlet. We always carry about 300 feet of electrical cord and our generator in case we don't find an outlet. We put the dogs back in the van, plugged in the air conditioner and went to our room.

Going back to the show grounds in the afternoon for Group, we had to stop half way at a gas station and soak the dogs with water. The brindle Bullmastiff was very distressed as was the Rottweiler. Arriving at the show grounds, we found a working outlet (by some miracle) and plugged in the air conditioner and the dogs were set.

I learned alot during that trip. Here are some tips you might be able to use in hot weather . . .

- 1) Always carry enough water from home for your entire trip (changing water can cause tummy upsets or diarrhea);
- 2) Carry at least one ice chest. You can use the ice to cool the dogs down from the outside and inside.
- 3) Take a water sprayer to wet down your dogs at the show grounds or even in your car;
- 4) Take plenty of towels to soak (in the ice chest) and drape over your dogs to cool them down. There are commercial wraps that have ice packs inside of them to freeze and use. These are good for one day.
- 5) Don't let your dog drink too much water, it could add to his discomfort and possibly bloat. Feeding them ice is a good idea.
- 6) Take plenty of breaks and take advantage of any shade around to exercise your dog in.
- 7) If your vehicle doesn't have air conditioning and/or your dogs are distressed while traveling, stop at gas stations and completely soak them in cool water. (I always carry a length of hose in the van).

Many people do many different things to keep their dogs cool in summer months. Do whatever works best for you. Bulldog people take ice chests filled with ice water to set their dogs in. I'm afraid this technique is impractical for Bullmastiffs!

# Ultrasound — What, When, Where and Why

I first learned about ultrasound when a local veterinarian gave a program on the subject at the kennel club I belong to. The machine looked somewhat like a tabletop computer and was hooked up to a V.C.R. It works something like radar, sound waves are sent into the subject, through the small wand that is attached with a cord. They bounce off objects and the images are sent back to be viewed on the screen. The screen is small and the picture fuzzy and confusing. The vet brought videotapes with her that showed a pregnant bitch. You could see little fetal sacks that looked dark with light centers, with tiny little heartbeats inside them. What you actually see is the dark then light of the heart valve opening and closing very fast. She also had tapes of puppies just hours before birth. Now we could see shapes that resembled puppies. Now we could see kicks, flips, turns, heartbeats and swallowing — yes, one swallowed. Ultrasound can also see livers with disease, kidneys with stones, hearts with murmurs and suspicious masses that could be malignant. It cannot see through bone, in fact bones are sometimes a problem as they throw shadows.

I first wanted to try ultrasound a few months later. We had bred our bitch T-Bone and about 18 days later she refused all food. I decided I was not going to forcefeed her if she was not pregnant, so I took her in on her 23rd day. We went into a room and the Doctor had T-Bone lie down on some foam covered with plastic which was changed after each patient. We turned her onto her back, and the Doctor put some jell on her belly for better contact (some coated breeds are shaved). She put the wand into the jellied area and we looked at the monitor. She's pregnant, the Doctor said right away. It took me a little longer to make out the shapes of the little sacks and the tiny heartbeats. The whole time this went on (about 10 min.) T-Bone was having a great time! She loves attention and with all the pets and praise it was hard to keep her still. Now I knew I'd have to force feed her, and I did for over 35 days, until the day she whelped.

One of the drawbacks of ultrasound is determining how many puppies there are. Just like X-ray there can be errors, but at least you can know one way or the other. Unlike X-ray ultrasound is perfectly safe to use, even every day of the pregnancy. I wanted to know to make sure my bitch got enough nutrition, you may want to know if there is a show circuit coming up so you don't waste entry money. Or if you suspect your bitch is resorbing puppies your vet can use it to determine if and when it happens.

We set up an appointment after hours for T-Bone to have a C-section. I had to count them twice and still couldn't believe it. There in our laundry basket were 14 squirming red babies each weighing about a pound.

We're glad we tried ultrasound and plan to use it again if and when it is needed. I hope I have helped someone else decide to try it and take advantage of its usefulness.

## Ultrasound vs. Radiograph — What We See

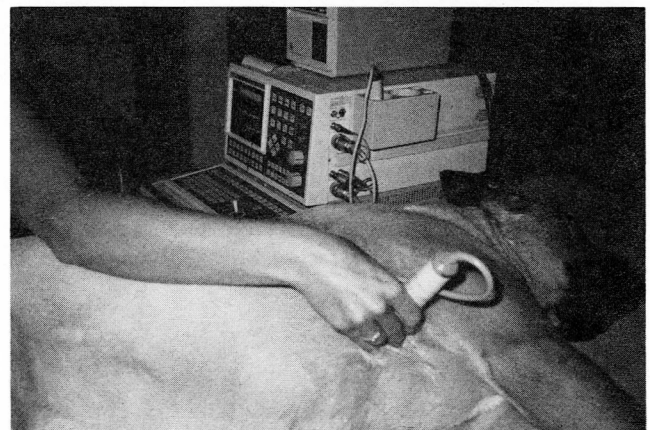
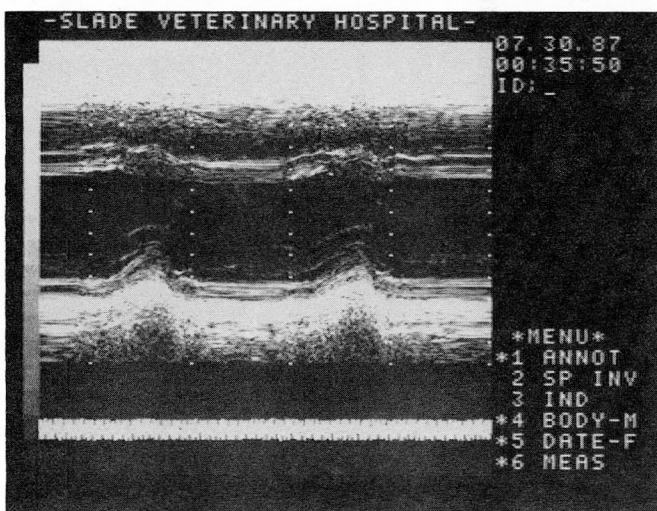
Radiographs ("x-rays") are black and white pictures that are a summation of 4 basic densities: bone, fat, fluid or air. For example, a chest radiograph depicts the heart as a white, solid fluid density surrounded by the black, air density in the lungs. But we all know that the heart is not really solid, but has internal chambers that vary in thickness, and valves, that separate the chambers.

In contrast, ultrasonography produces a picture that is a cross-sectional image — the heart muscle, the valves, and internal chambers are seen as separate entities. Each part of the heart bounces sound waves back to the receiver and one picture is displayed with all the parts separated, not summed, as with a radiograph.

### KEY REPRODUCTIVE POINTS

- 1— Uterine enlargement can be detected at 7 days gestation and the embryo can be seen at 10 days. Implantation in the bitch usually occurs at day 17, so the presence of pregnancy is rarely evaluated before 18 to 21 days. Before this time, false negative readings are very possible.
- 2— The actual fetus is difficult to see before day 28 and the fetal structures, including the beating heart, are seen by day 35.
- 3— Determining the exact number of feti is difficult since some may be located behind loops of bowel, or with large litters, they may be deep in the cranial abdomen.
- 4— You still have to wait till that "BIG DAY" to determine the sex.
- 5— The viability of feti can be evaluated after 30 days in gestation by observing fetal cardiac activity.
- 6— Fetal death is determined by the lack of fetal heart motion or fetal movement, abnormal fetal shape or abnormal echoes in the amniotic fluid.
- 7— Pyometra, endometrial cysts or masses can also be detected using ultrasonography.
- 8— The normal ovaries are extremely difficult to identify since they are small and similar to surrounding tissues. Ovarian tumors can be detected, but may be difficult to distinguish from enlarged lymph nodes and other masses.
